

## FOSTER CARE AGREEMENT

We at the Joshua Fund, Inc. ("We/Us") appreciate your commitment to the safe care of the dog placed in your care. As part of our Foster Care program we have found that it is best to have a clear agreement that setting forth the expectations and requirements regarding the care of the dog(s) in your temporary custody.

- 2. <u>No ownership.</u> You acknowledge that no rights of ownership of the Foster Dog are granted or transferred by Us to You, and that We maintain absolute ownership of the Foster Dog. For the purposes of clarity, the parties hereto explicitly intend the relationship created hereby to be one of bailor, with respect to Us, and bailee, with respect to You.
- 3. <u>Return of the Foster Dog.</u> You hereby agree to return the Foster Dog to Us upon the sooner to occur of the termination of this Agreement, or upon request by Us. The Foster Dog shall be returned to the personal custody of a representative of the Joshua Fund, Inc. You agree to immediately contact Us to arrange for the return of the Foster Dog if You no longer desires to provide care for the Foster Dog.
- 4. <u>No Compensation</u>. You hereby acknowledge that we are not obligated to pay You any compensation for taking care of the Foster Dog.
- 5. <u>Reimbursement</u>. Notwithstanding the foregoing Article 4, We will provide reimbursement to You for documented, actual, reasonable and necessary expenses of caring for the Foster Dog, including, but not limited to: dog food, dog biscuits, approved veterinary expenses, and the like. Unless there is an emergency which You reasonably believe, in good faith, threatens the life of the Foster Dog, You must obtain prior written approval for all veterinary visits and expenses incurred. In the event of an emergency, we reserve the right to determine whether and how much, if any, of a reimbursement We will provide to You.

## 6. <u>Care of the Foster Dog.</u>

(i) <u>Suitable Premises</u>. You agree that: (i) You have obtained any necessary permits, consents or municipal requirements to house the Foster Dog at the Premises, (ii) the dog will reside exclusively at the Premises for the duration of this Agreement, and (iii) the Premises are indoor, humane, climate controlled and in all ways suitable and appropriate for the housing of a delicate animal which may be in poor health. You agree to provide adequate food, water,

shelter, and humane treatment and for the Foster Dog at and local laws and with all oral and/or written instruct	all times. Further, You agree to comply with all applicable state ions from Us.	
(ii) <u>Time Alone, Recreation</u> . You agre six (6) hours at a time. You agree that humane treatmen recreation for the Foster Dog. The Foster Dog shall be lea	te that in no event shall the Foster Dog ever be alone for more than nt of the Foster Dog includes providing exercise and outdoor shed or otherwise restrained whenever taken outdoors.	
(iii) <u>Removal from Area</u> . You agree the Premises, nor be removed from more than without prior written consent from Us, which consent mo	hat the Foster Dog shall not reside anywhere else other than the () miles from the Premises for any amount of time iy be granted or denied it our sole discretion.	
(iv) <u>Appearance</u> . You agree not to che animal, or cropping its ears or tail, without Our prior ag	ange the appearance of the Foster Dog, including by declawing the proval.	
(v) <u>Muzzle</u> . The Foster Dog shall no	t be muzzled.	
7. No Liability. You agree to indemnify and hold Us harmless from and against any and all claims, expenses, demands, losses, costs, fines or liabilities of whatever kind or nature (including, without limitation, arising from personal injury or property damages), and reasonable attorney's fees and expenses, in any way related to the Foster Dog. We make no representation as to the health, condition or temperament of the Foster Dog. The provisions of this paragraph shall survive termination of this Agreement.		
This Agreement represents the entire agreement between You and Us with respect to the subject matter hereof, and supersedes all prior agreements or understandings between You and Us. This Agreement shall be construed in accordance with the laws of the State of New York, without reference to the conflicts of laws principals thereof.
